

# First Time Login Potential Industry Professionals – Education Eligibility

The first time login process for potential industry professionals is not complete until an Education Eligibility, Licence Mobility or Suitability Review application is submitted to RECA, so make sure you have at least 30 minutes of free time before beginning. ## Eligibility Requirements

All industry professionals must complete pre-licensing education to become licensed. To enrol in this education, you must first meet the basic eligibility requirements. RECA determines your eligibility by reviewing an Education Eligibility Application.

To complete the Education Eligibility Application:

- · answer the online eligibility questions and pay the application fee
- upload supporting documents
- · request additional documents be sent to RECA from third-parties (i.e. education institutions, etc.)

You must complete your application within six months of paying the fee. RECA will contact you regarding your eligibility once we receive a complete application.

IMPORTANT: if you close your screen or cancel out of this process before you finish, your information will not be saved.
