5. Lawyers Trading in Real Estate

Management discussed the licence exemptions for members of the Law Society of Alberta.

The Registrar described the robust process and collaborative evaluation approach applied to whether section 2 exemptions apply in specific circumstances.

6. FINTRAC Requirements

Management discussed the FINTRAC reporting requirements.

FINTRAC has accepted that lawyers are protected by client privilege and they are not required to disclose or report. RECA has no jurisdiction to affect what FINTRAC might require. The Canadian Real Estate Association has a brochure that is concise and succinct, as well as a document of frequently asked questions on Proceeds of Crime (Money Laundering) and Terrorist Financing.

The Registrar compared and contrasted the various and distinct jurisdictions as between RECA and FINTRAC.

<u>ACTION</u>: While there is nothing further RECA can do with this concern at this juncture, the Industry Council Chair suggested this be raised to the Board for contemplation in the next strategic planning process – perhaps, as one suggestion, developing a strategic process for RECA to weigh in on issues over which we have no jurisdiction but that affect the industries RECA regulates.

7. Stakeholder Engagement

Management discussed the Commercial Real Estate Broker and Commercial Property Manager Industry Council External Communications plan.

<u>ACTION</u>: Management will take steps to identify stakeholder groups in the agriculture community that RECA can engage with.
