The Industry Council will need to prescribe competency profiles and learner outcomes for residential real estate associates and collaborate with other Industry Councils on the competency profiles and learner outcomes for real estate brokers.

<u>ACTION</u>: The Industry Council will select two (2) members to participate in meetings to review the competency profiles and learner outcomes.

## 6. Reporting Accepted Offers

The Industry Council reviewed a confidential and privileged legal opinion on the reporting of accepted conditional offers and agreed that further clarification was required.

<u>ACTION</u>: Management will invite external legal counsel to attend the August 10, 2021 Industry Council meeting to provide further clarification and advice.

#### 7. Residential Measurement Standards (RMS) Review

The Industry Council reviewed terms of reference for a proposed adhoc RMS Committee.

<u>ACTION</u>: Management will revise the RMS Committee terms of reference presented at this meeting as follows:

- Amend so that the Board Chair is a non-voting member of the Committee; and
- Consider adding a sentence regarding possible remuneration for Committee members.

<u>MOTION</u>: The Residential Real Estate Industry Council requests and recommends to the RECA Board of Directors that it:

- establish a Residential Measurement Standards (RMS) Ad-Hoc Committee; and
- approve the terms of reference of the RMS Committee as presented and amended at this meeting.

The Industry Council instructs its Industry Council Board member to present this request and the proposed terms of reference to the Board for approval at its next meeting on July 29, 2021.

<u>ACTION</u>: The Industry Council will have a discussion on three (3) issues on RECA's Advertising Guidelines at the next meeting:

- Representation or misrepresentation;
- Brokerage name not being clearly indicated; and
- Incentives.

<u>ACTION</u>: Management will provide a briefing note on the *Real Estate Act* rules around advertising and the source of RECA's authority.

The Industry Council discussed including a refresher on the broker resolution program in the next communication to the industry.

#### Guaranteed Sales

The Industry Council discussed guaranteed sales and the need to consult with the industry on this topic. The Industry Council determined that this topic would be placed on a future meeting agenda for further discussion and that consideration be given to forming a working group.

#### 10. Publication Guidelines

The Industry Council discussed the feedback received from Industry Council members on the publication guidelines.

<u>ACTION</u>: The Industry Council will hold further discussions on the publication guidelines at its September 7, 2021 Industry Council meeting.
