3. Education Framework & Divestment Update

Education Framework

Management provided an update on the education framework and divestment activities.

The Education Framework Discussion Group is scheduled to meet on June 17, 2021 to review stakeholder feedback on the education framework and make its final recommendations to the Board and Industry Councils.

Management is recommending the Industry Council agree to hold an electronic vote shortly after June 17, 2021, with the purpose of recommending to the Board the Pre-Licensing Education Philosophy, the Course and Course Provider Requirements and the Examination Blueprint for the Board's special meeting on June 22, 2021. The Industry Council agreed with this approach.

Competencies and Learner Outcomes

Management discussed that the Industry Council will need to prescribe competency profiles and learner outcomes for commercial and rural real estate associates and will need to work with other Industry Councils to prescribe the competency profile and learner outcomes for real estate brokers and property manager associates.

Management recommends a six-person discussion group be formed with two Industry Council members from each of the Residential Real Estate Broker, Commercial Real Estate Broker and Commercial Property Manager, and Residential Property Manager Industry Councils to complete a joint review of the Real Estate Broker and Property Manager Competencies and Learner Outcomes prior to the September 9, 2021 meeting of the Industry Council. Ms. Brittanee Laverdure and Mr. Ben Van Dyk volunteered to be part of this discussion group.

Management recommends a four-person discussion group be formed with two Industry Council Members from each of the Commercial Real Estate Broker and Commercial Property Manager, and Residential Property Manager Industry Councils to do a joint review of the Property Management Competencies and Learner Outcomes. Ms. Cheri Long and Ms. Laura Sharen volunteered to be part of this discussion group.

4. Stakeholder Engagement

Management provided the Industry Council with an update on stakeholder engagement activities.

The Commercial Industry Council Online Engagement Session held on June 2, 2021 had 172 people registered and 101 attend.

The Industry Council expressed concern that many of the large brokerages did not attend the engagement session.

The Industry Council reviewed the proposed responses to emails received to the Industry Council email address. The Industry Council agreed to the responses.

Management discussed upcoming engagement activities, including the August issue of the Regulator, and scheduling of Broker and 20/20 Forums in September 2021.

5. Calendar 2021/2022 Meetings

The Industry Council reviewed the calendar for 2021/2022. The Industry Council agreed to the following regular meeting dates. Additional meetings could be scheduled as required:

6. NAIOP & BOMA Request Update

The Industry Council discussed communication with NAIOP and BOMA regarding the recent proposed amendments to the *Real Estate Act* and potential rule changes. NAIOP and BOMA have agreed to provide the Industry Council with further input and feedback in June/July 2021.

7. Election Criteria & Process

The Industry Council discussed the feedback received from the Industry Council members on the election criteria and process.

<u>ACTION</u>: Management will send a revised draft of the Urban Commercial Practitioner election criteria to the Industry Council members.

8. Publication Guidelines

Management advised it will canvass each Industry Council member for feedback on the Publication Guidelines.
