6. Condominium Property Act (CPA) Amendments Update

The Industry Council had a brief discussion about the Condominium Property Act amendments and progress towards implementation.

7. Condominium Manager Licensing Update

For this information item, Management provided an update on the process of onboarding condominium managers into RECA's licence registry.

<u>ACTION</u>: Follow up a few months after initial licensing on December 1 to evaluate whether all condominium managers have been identified and to consider next steps as necessary.

<u>ACTION</u>: Management will suggest to Service Alberta that Land Titles retain information about how each condominium corporation is managed, i.e. self-managed, managed by an employee, managed by a licensed manager, etc.

11. Feedback on New Information Bulletin

The Industry Council provided feedback on a proposed information bulletin for condominium manager assistants.

ACTION: Management will provide the Industry Council with a digital copy of the information bulletin and the Industry Council will provide feedback to Management as soon as possible.

12. Residential Measurement Standards (RMS)

The Residential Real Estate Broker Industry Council recently established a Residential Measurement Standards (RMS) committee to review RECA's RMS. As the work of this committee will impact the Property Manager Industry Council, Management is requesting the Industry Council select two (2) individuals to sit on this committee, one of whom would ideally be from the Council, potentially to serve as vice-chair of the committee.

ACTION: Management will provide additional information about the RMS Committee to the Industry Council.
