3. RECA Board of Directors Report

4. Reporting Accepted Conditional Offers

Management presented the updated "The Real Estate Act & Board Rules" Information Bulletin for the Industry Council's review and consideration based on direction given from the Industry Council at its August 10, 2021 meeting.

ACTION: Management will revise the wording in "The Real Estate Act & Board Rules" Information Bulletin as further discussed at this meeting.

ACTION: Management will create a plan to communicate the amended "The Real Estate Act & Board Rules" Information Bulletin to the industry.

MOTION: The Residential Real Estate Broker Industry Council instructs Management to take down a 2012 blog and a 2013 video from the RECA website around disclosure of accepted conditional offers and to post the amended version of "The Real Estate Act & Board Rules" Information Bulletin as further discussed and amended at this meeting.

7. Condominium Manager Licensing Update

For this information item, Management provided an update on the process of onboarding condominium managers into RECA's licence registry. Currently, there are 170 individuals in the eligibility process.

8. Education Programs Update

Competencies Profile

The Industry Council discussed the Residential Real Estate Associate Competency Profile. Given the level of detail provided in the Competency Profile, the Industry Council is relying on the experience and expertise of Management to guide them through this process.

Proposed Validation Survey

Management discussed the proposed process to validate the Residential Real Estate Associate Competency Profile.

- 1. Each of Alberta's real estate boards and AREA will be given the opportunity to set-up member committees to review and provide feedback.
- 2. All real estate associate licensees and real estate brokers will be given an opportunity to complete the survey.

The proposed consultation period will be 30 days.

<u>MOTION</u>: The Residential Real Estate Broker Industry Council directs RECA Management to undertake a validation survey of the Real Estate Associate Competency Profile using the process presented at this meeting.

Management discussed the proposed Education Transition Plan with the Industry Council. The Board asked that the draft Education Transition Plan be circulated to the Industry Councils for feedback in anticipation of their September 24, 2021 meeting.

<u>MOTION</u>: The Residential Real Estate Broker Industry Council confirms that it has been consulted on the Real Estate Act (REA) bylaws and recommends that the RECA Board of Directors adopt and approve the proposed REA bylaws as presented and further amended in "TAB 14.1B Bylaws Amended Draft – September 2, 2021" of the meeting material.

Election Policy & Process

Management discussed the proposed Industry Councils' Elections Policy and Process, and the Industry Council suggested a few changes.

ACTION: The Industry Council requested Management amend the Residential Real Estate Broker Industry Council eligibility requirements so that at least one (1) of the elected residential real estate broker Industry Council licensees must be a real estate broker and at least (1) must be a real estate associate. The Industry Council also recommended that a real estate broker delegate would not qualify as a real estate broker for the purposes of election eligibility requirements.

<u>MOTION</u>: The Residential Real Estate Broker Industry Council recommends that the RECA Board of Directors approve the Industry Councils' Elections Policy and Election Process in the form presented and amended at this meeting.
