- Your reasons for the appeal: why is the Registrar's decision wrong?
- What evidence did you provide to the investigator that shows the decision is wrong?
- Is there legislation or case law that supports your reasons?

Send your summary by email, fax or mail to the Hearings Administrator, and the Administrator for Counsel for the Registrar (contact information below) by Friday, March 11, 2022.

The Registrar has 2 weeks to reply. You will receive a copy of this reply.

You may reply to the Registrar's reply. You have **1 week** to send your reply to the Hearings Administrator after you receive a copy of the reply.

The Panel will receive your summary and the Registrar's reply before the hearing.

Why You Should Attend the Hearing

The hearing is your opportunity to argue your side of the case in front of the Panel and answer any questions they have.

What Will Happen if You Don't Attend

If you do not attend the Panel may proceed to make a decision without you.

What Will Happen at the Hearing

After reading the arguments and hearing from you and the Registrar the Panel must make one of the following findings under section 40(2) of the *Real Estate*Act:

- The complaint is frivolous or vexatious
- There is insufficient evidence of conduct deserving of sanction, or
- There is sufficient evidence to warrant a hearing on the conduct.

If the Panel finds that the complaint was frivolous and vexatious, it can order you to pay the costs of the investigation into your complaint and your appeal. This is very rare however.

You Can Get Legal Advice

You can get advice from a lawyer for your appeal, and you may have a lawyer

represent you in the appeal.

If You Object to a Panel Member

Please review who is on the Panel. If you object to any of the people being on

the Panel, tell the Hearings Administrator who you object to and why within

14 days of receiving this Notice.

If you do not object to the Panel within 14 days, this Panel will conduct the

hearing.

Postponing the Hearing

If you are not available the date set for the hearing you can ask to the Panel

for a new date. Contact the lawyer for the Registrar and the Hearings

Administrator as soon as possible if you need a new date.
