4. Consent Agenda

Property Manager Associate Competency Profile

Management discussed the Property Manager Associate Competency Profile and corresponding weightings. Six percent of possible respondent's replied to the validation survey sent to industry in October 2021. Management also collected feedback from the Building Owners and Managers Association ("BOMA") of Edmonton and Calgary, and NAIOP, the Commercial Real Estate Development Association.

Two Industry Councils are reviewing the Property Manager Associate Competency Profile and weightings, being the Residential Real Estate Broker Industry Council and this Industry Council. Management discussed recommendations.

<u>MOTION</u>: The Commercial Real Estate Broker and Commercial Property Manager Industry Council approves the Property Manager Associate Competency Profile and Competency Weightings as presented in "TAB 10(2)B" of the meeting material, and as amended at this meeting.

• Real Estate Broker Competency Profile

Management discussed the Real Estate Broker Competency Profile and corresponding weightings. Management noted that 16% of real estate brokers replied to the validation survey that was sent to industry in October/November 2021. The Alberta Real Estate Association (AREA) provided feedback through the Broker Education Working Group.

Three Industry Councils are reviewing the same profile, being the Residential Property Manager Industry Council, the Residential Real Estate Broker Industry Council and this Industry Council. Management discussed recommendations.
