The Industry Council reviewed the action register. RECA Management ("Management") will review licensee recidivism in response to the Auditor General of Ontario report on the Real Estate Council of Ontario.

7. Regulatory Activity Scorecard

Management presented the Regulatory Activity Scorecard as information.

8. RECA Board of Directors Report

The Industry Council's Board member provided a report on the activities of the RECA Board of Directors ("Board"). The Industry Council discussed the Mortgage Professionals Canada conference (October 15 – 17, 2022) and Mortgage Broker Regulators Council of Canada meeting (October 18 and 19, 2022).

9. Industry Council Annual Evaluation Process

10. Credentialing Report and Course Provider Update

Management discussed proposed amendments to RECA's Discipline Publications Guidelines, created January 2018 ("Guidelines") in response to stakeholder feedback. The Board and Industry Councils have committed to reviewing the Guidelines.

Management will conduct a review of course competencies to ensure private lending is adequately addressed.
