

5. Staggered Terms for Board and Industry Council Members
Management discussed the proposed amendments to *Real Estate Act*("REA") Bylaw 3.1. The amendments would introduce staggering into
RECA Board and Industry Council member terms.

Service Alberta and Red Tape Reduction was consulted and confirmed they would strive to establish staggered terms for public member appointments.

Management discussed that in March 2023, RECA's four (4) Industry Councils were consulted on the proposed amendments. There was support for the proposed bylaw amendments from three of the Industry Councils, however, not all members of the Residential Real Estate Broker Industry Council were in support of the proposed bylaw amendments.

MOTION: Following consultation with RECA's four Industry Councils and Service Alberta, the RECA Board of Directors approves the proposed amendments to Real Estate Act Bylaw 3.1 as presented in TAB 2 and directs RECA Management to submit to the Minister of Service Alberta & Red Tape Reduction, for final approval.
