# 6. Industry Council Calendar

Management recommended that the Industry Council advance its December 2023 meeting to November 2023, due to the Industry Council member elections and appointments with new terms commencing December 1, 2023. The Industry Council accepted the recommendation, as proposed.

#### 7. RECA Board of Directors Report

The Chair introduced a report on the activities of the RECA Board of Directors ("Board"), which was received as information.

#### 8. Broker Forum Update

Management presented the topics raised at the Broker Forums (Calgary, Edmonton). Discussions included the introduction of a mentorship program in the commercial sector, licensee turn-over (retention), and education (commercial course competencies).

#### 9. Real Estate Act ("REA") Rules Review Steering Committee

Management provided all responses received by the Rules Review Steering Committee, in response to the <u>Phase One Discussion Paper</u>. An analysis was provided to highlight key areas. Topics of interest are digital business (allowing virtual offices), licensing structures, and notice periods ("immediately notify"). Phase Two will review *REA* Rules 2-40. Primary audiences of Phase Two include all licensees, industry and trade associations, Industry Councils, Government, consumers, RECA staff, and

bodies governed by the *REA* or *REA* Rules (AREF & REIX). Secondary audiences are all provincial regulators and related professions (real estate lawyers, appraisers, and insurers). Proposed *REA* Rules for part one of Phase Two are under development.

<u>ACTION:</u> The Industry Council September meeting will be lengthened to discuss Rules Review Steering Committee consultation results to date.

Management presented the credentialing report and learner success rates, which were received as information.
