7. Industry Council Annual Self-Evaluation Results

Management presented the results of the 2023 Industry Council annual self-assessment in accordance with s. 4.4 of the *Real Estate Act* Bylaws. The Industry Council agreed it has addressed the right issues, is effective in its work, and is satisfied with its performance. The Industry Council identified areas of improvement, which included creating a long-term strategy to address the needs of industry.

The Industry Council Chair will confer with Management to revise some of the questions for the 2024 annual self-assessment.

8. Industry Council Strategic Planning Workplan

The Industry Council considered the creation of a workplan to enhance strategic planning, to create a timeline for completion of tasks, to identify resources required and responsible parties, and to monitor and evaluate risks. The Industry Council committed four preliminary items to the workplan, the details of which will be reviewed at the next meeting.

9. Rules Review Committee Activities to Date

Management reported on the activities of the Rules Review Steering Committee to date, which included the Phase Two, Part One consultation results, and the consumer focus group results. Consultation on Phase Two, Part Two will continue while the Committee completes its review of Phase Two, Part Three questions to industry.

10. Preliminary Recommendations from the Rules Review Steering Committee

Management reported that, at its meeting of February 15, 2024, the Rules Review Steering Committee recommended the following to all Industry Councils for consideration.

- 1. A single licence with sectoral authorizations with all seven sectors.
- 2. That existing brokers, associate brokers, and associates' current authorizations are grandfathered.
- 3. That related licenses need to be at the same brokerage.
- 4. That the licensing structure contain principal broker and associate broker classes in the mortgage broker sector.
- 5. To allow brokers to approve individual incentives, rather than brokerage-wide incentives.

The Industry Council discussed the recommendations, which will return before the Industry Councils during the March 2024 cycle of meetings.
