7. Service Alberta and Red Tape Reduction Five-Year Review of RECA Management reported that Service Alberta and Red Tape Reduction (SARTR) will conduct its third-party review of RECA starting July 2025.

8. Education – Views on RECA Role/Involvement

The Industry Council received the *Credentialing Report and Learner Success Rates*. The Industry Council considered RECA's divestment of education through the *Real Estate Amendment Act* 2020. RECA continues to provide feedback, shared by learners, with the approved pre-licensing third-party course providers. The Industry Council would appreciate an audit mechanism to assess course quality.

9. Graduated Licensing Pilot Project – Property Management

Kristian Tzenov, RECA Stakeholder Engagement Manager and Regulatory Compliance Advisor, joined the meeting

Management reported the results of the property management survey, which polled industry interest in a graduated licensing pilot project for property managers (both residential and commercial). RECA polled for similar interest in 2018-2019. The concept was received positively. The pilot project would not be mandatory for all brokerages but would be optional for those who expressed interest.

<u>ACTION</u>: Management will develop a pilot project framework for property management licensees, for the Industry Council's review.
